Tuition

Tuition fees are applied towards the cost of instruction at Celandine Life Prep Academy, Inc. Please note that tuition and fees include the following:

1. All Program Services
2. Enrollment fee
3. Activity & Supply fee

Tuition does not cover the following fees, some of which are optional:

1. Your initial screening fee (for new students only)
2. Application fee (for new students only)
3. National Background Screening fee - initial or 5-year re-screening only.
4. Before/after care programs
5. Lunch options
6. Chaperone fees
7. Uniform shirts
8. Themed CLPA clothing

Family Empowerment Scholarship – Unique Abilities (FES-UA)

1. Parents are responsible for filing their application and/or intent to continue in the Step Up for Students FES-UA scholarship by the deadline set forth by the Florida Department of Education.
2. If a parent does not file for the FES-UA scholarship by the set deadline, they have the option to either pay the tuition for their child until funding for their child becomes available from the FES-UA scholarship or withdraw their child from the school.
3. ***FES-UA funding amount are direct deposited to the school.
4. An individual tuition estimate has been developed. All tuition estimates must be signed and payments must remain current in order to ensure continued enrollment with Celandine Life Prep Academy. Payment plans will be made available based on the school budget. Attendance at school without a signed tuition agreement will be considered acceptance of the proposed tuition agreement and the parent/guardian will be responsible for all applicable fees.
5. In the event of additional tuition due because of funding cuts to the FES-UA Scholarship or incorrect matrix information provided to the school, you will be notified immediately. Providing all tuition payments are kept current, payment plans will be made available for additional tuition costs.
6. Please note that due to new changes to FES-UA, if your child is absent for more than 10 days for a medical condition, they must be un-enrolled and will not receive the upcoming quarterly scholarship payment. Your child will still most likely be eligible for FES-UA and can be re-enrolled once they return with appropriate medical documentation however you will then become responsible for the quarterly payment that was missed.
7. If payment is not received based upon the parent signed program agreement (to include before/afterschool programs, tuition or any other program the parent believes will be paid for by FES-UA), within 3 months' time from date of invoice submission, the parent is responsible

for all amount(s) due. If and when the payment for aforementioned programs is received from FES-UA, the parent will be reimbursed pending any additional, outstanding balances.
